A message from Jon Cooke, Chair

When, back in 2008 we first began to raise awareness of the need for increased energy efficiency and tried to encouraged a culture of climate care in the community, we met a certain amount of derision and sometimes a strong anti-climate change lobby. "It wasn't happening; there wasn't a problem; we were seen by some as a bunch of "eco warriors" outside the mainstream of the community.

It's interesting to observe how gradually the scene has changed. Having provided hundreds of free home energy audits, organised films and lectures by high profile speakers and been a constant source of non-biased and sensible advice, Stretton Climate Care has become a respected part of the community. We are often the first port of call for advice on energy efficiency and increasingly invited to work alongside other organisations that are seeing "sustainability" as an important part of their remit. We continue to be asked to talk to community groups about the work that we do and our volunteers in their blue fleeces are a familiar sight around the town.

Nationally it has been a frustrating year with Government indecision and backtracking on Feed in Tariffs and courageous polices for carbon reduction watered down. Locally we have plodded on with our free home energy audits, encouraged dozens of households to take advantage of free loft and cavity wall insulation and worked with others on an exciting external insulation project with the Town Council. We value our volunteers and loyal membership who have stayed with us and encouraged and supported the work that we do.

We look forward to the opportunities presented by The Green Deal which is expected to be launched in October 2012.

Our Mission Statement:

To advance environmental protection and improvement by reducing the carbon footprint of the local area.

Our Aims within the local area:

- To encourage a culture of climate care
- To encourage low carbon, sustainable lifestyles
- To raise awareness of and reduce emissions of other climate change gases
- To encourage households and businesses to reduce energy consumption
- To encourage waste reduction generally and increase recycling
- To reduce fuel poverty
- To encourage local trading
- To encourage carbon offsetting by local people who cannot avoid having higher carbon lifestyles

Review: April 2011 to March 2012-Our Key Achievements

- We encouraged the fitting of loft & cavity wall insulation to many properties together with a number of solar photo voltaic installations
- Our volunteers carried out 50 Household Energy Checks providing advice on energy efficiency which has led to an estimated average of 13% reduction in carbon emissions for our previously assessed households. Held drop in advice service at Jemima's Kitchen at Victoria House and carried out targeted campaigns in Little and All Stretton
- Maintained a membership of 82 members
- Initiated a special project in the Battlefield area encouraging the three similar streets to compete to reduce their energy use. We have held local meetings and workshops and commissioned a report from Redbox Research on the local attitudes to energy efficiency and climate change
- Held the fourth annual duck races at Carding Mill Valley showing that low carbon recreation can be fun!
- Published and widely distributed our newsletter on 4 occasions keeping our membership & community informed about climate change issues, worked with local schools and maintained a lively website and frequent coverage in the press
- Established a low energy bulb recycling point with the support of Acorn Cafe
- Held our second Low Carbon Homes Trail where 8 local householders and two community buildings opened up their properties to explain what they had done to reduce their fossil fuel energy use and costs. Specialist contractors were on hand to give advice on renewable energy and insulation
- Organised a joint photo competition with Long Mynd camera club on the theme of responding to climate change in Shropshire
- Held a 1940's theme dance, participated in the Summerfest, held a joint lecture on the ethics of nuclear power and showed a film on The Economics of Happiness
- Worked in partnership with Church Stretton Town Council on the government grant aided project to insulate the Town Council offices by publicising the proposals in the community
- Responded to consultations deploring the excessive reduction in support for solar PV installations
- Kept our carbon footprint and running costs low by reducing our travel and using electronic communications.

Stretton Climate Care: Organisation and other Facts

Finance

We were successful in gaining income from a variety of sources including commisssion on solar PV installations. We managed our expenditure accordingly so that we continued to grow our balance during the year. It is the policy of Stretton Climate Care to operate as far as possible with a financial reserve equivalent to at least 9 months of our annual expenditure, and we comfortably exceeded that. The Executive Committee receives a Report analysing expenditure and income at each of its meetings and controls expenditure accordingly.

Public Benefit

The Trustees of Stretton Climate Care have had regard to providing public benefit in delivering our services in accordance with advice from the Charity Commission. In particular our main service is to assess and advise on the carbon footprint and energy use of households and provide advice where appropriate on reducing this. This service is provided free of charge to any household in the community and we do our best to give priority to households in fuel poverty. This is in line with our Charitable objects which provide public benefit. We provide subsidiary activities and services, such as environmental films that are either free or subject to a small charge to cover costs. Other activities such as the duck race are intended to attract additional households to our service and although there is small charge for entry, our household advice service is free. We have also provided fee paid advice to other bodies establishing similar services to other communities. Our activities also generate opportunities to advance education about conserving, protecting and improving the environment.

Other Information


